

WELCOME TO SANTA CATARINA!

PLEASE PAY ATTENTION TO THE RULES FOR TRANSPORTING ANIMALS, VEGETABLES, SEEDS AND SEEDLES, AND PRODUCTS OF VEGETABLE AND ANIMAL ORIGINS.

ANIMAL PRODUCTS



UNAUTHORIZED ITEMS: RAW BEEF OFFAL FROM ANY OTHER PART OF BRAZIL; HONEY AND BEEKEEPING PRODUCTS IMPORTED FROM OTHER COUNTRIES; PRODUCTS OF SWINE ORIGIN FROM THE BRAZILIAN STATES OF ALAGOAS, AMAPÁ, PART OF AMAZONAS, CEARÁ, MARANHÃO, PARÁ, PARAÍBA, PERNAMBUCO, PIAUÍ, RIO GRANDE DO NORTE, RORAIMA AND COUNTRIES WITH AFRICAN SWINE FEVER (ASF) AND CLASSICAL SWINE FEVER (CSF) OUTBREAKS.

RESTRICTION: MEAT, FISH, MILK AND DAIRY PRODUCTS MUST BE IN ORIGINAL MANUFACTURER'S PACKAGES, PROPERLY LABELED AND OFFICIALLY SEALED BY THE INSPECTION SERVICE.



IN CASE OF IRREGULARITIES, THE PRODUCTS MAY BE SEIZED AND DESTROYED IN ORDER TO PREVENT OUR ANIMAL'S CONTAMINATION. THE CARRIERS ARE SUBJECT TO PENALTIES.

VEGETABLES, SEEDS AND SEEDLES



SEEDS AND SEEDLES: THEY MUST BE LABELLED WITH THE PRODUCER'S DATA AND INVOICE.

BANANA, APPLE, GRAPES, CITRUS AND OTHER FRUITS: A TRANSIT PERMIT FOR VEGETABLES (PTV) MAY BE NECESSARY TO ATTEST THE PHYTOSANITARY CONDITION OF THE PRODUCTS.

CATS AND DOGS: A HEALTH CERTIFICATE ISSUED BY A VETERINARY DOCTOR MUST BE PRESENTED. AN INTERNATIONAL HEALTH CERTIFICATE IS REQUIRED FOR INTERNATIONAL TRAVEL.

OTHER ANIMALS: THE OFFICIAL BRAZILIAN ANIMAL TRANSIT DOCUMENTATION (GTA) IS NECESSARY AS WELL AS MANDATORY EXAMS AND OTHER REQUIREMENTS FOR ANIMAL HEALTH DEFENSE.

DISTINCTIONS OF SANTA CATARINA

SANTA CATARINA IS THE ONLY BRAZILIAN STATE CERTIFIED BY THE WORLD ORGANIZATION FOR ANIMAL HEALTH (OIE) AS A FOOT-AND-MOUTH DISEASE (WITHOUT VACCINATION) AND CLASSICAL SWINE FEVER FREE ZONE. IN ADDITION, SANTA CATARINA PRESENTS ONE OF THE LOWEST PREVALENCES OF BRUCELLOSIS AND TUBERCULOSIS IN BRAZIL.

FOR VEGETABLES, SANTA CATARINA IS FREE FROM THE BANANA MOKO DISEASE AND CODLING MOTH, WHICH IS CONSIDERED THE WORST INSECT PLAGUE OF FRUITCULTURE.

THOSE CERTIFICATES DEMONSTRATES EXTREME CARE FOR THE HEALTH OF ANIMALS AND FARMS

PERMANENT SURVEILLANCE

ENSURING THE HEALTH OF ANIMALS AND FARMS IS EVERYBODY'S DUTY. THE COMPANHIA INTEGRADA DE DESENVOLVIMENTO AGRÍCOLA DE SANTA CATARINA (CIDASC) KEEPS 63 FIXED SANITARY BARRIERS AT THE BORDERS WITH THE STATES OF PARANÁ AND RIO GRANDE DO SUL AS WELL AS WITH ARGENTINA IN ORDER TO CONTROL THE TRANSIT OF ANIMALS AND AGRICULTURAL PRODUCTS.
